D. RETENTION NOTICE:

Risk in any goods supplied by Western Pet Supplies to the customer shall pass when such goods are delivered to the customer or into custody on the customer's behalf but ownership in such goods shall be retained by Western Pet Supplies until payment is made for the goods. Until such payment has been made in full the customer shall hold the goods as bailee only for Western Pet Supplies. Should any goods sold become constituents of or be converted into other products while subject to Western Pet Supplies ownership shall extend to those other products. If the customer defaults on the payment, or enters bankruptcy, liquidation or has a receiver appointed it shall be lawful for Western Pet Supplies, without notice, to enter the customer's premises where the goods may be and take possession of them. If the customer re-sells the goods before legal ownership has passed then the customer shall be deemed to be acting as Western Pet Supplies agent and shall therefore keep the proceeds separate from any other monies and account to Western Pet Supplies.

F. TERMS AND CONDITIONS OF TRADE:

PRO FORMA

All goods must be paid in full by either:

- 1. Electronic Funds Transfer to our account before goods will be dispatched.
- 2. Bank cheque or cash on delivery of goods to your premises or collection of goods from Western Pet Supplies. C.O.D.

All goods must be paid in full by either:

- 1. Cash or cheque on delivery of goods to your premises or collection of goods from Western Pet Supplies.
- 2. A 2% surcharge will be charged on all credit card payments.

NEW CUSTOMERS AND SHOP OWNERS

- 1. The first three (3) orders placed will be paid for on a PRO-FORMA basis (see above)
- 2. Trading terms will then be given from the fourth order onwards, subject to the value of orders previously placed, the transaction history, and trade reference check outcomes.

ACCOUNTS

- 1. Should an account be granted, the applicant will be informed in writing. All orders in the interim period will be supplied on a COD or PRO-FORMA basis only.
- 2. Account terms will commence as either 14 days from invoice date (where monthly purchases are less than \$5,000), or 21 days from invoice date (where monthly purchases exceed \$5,000).
- 3. A risk factor will be applied in accordance to the accumulated trading history of the account.
- 4. Should payment fall outside of account terms, and becomes past due on a reoccurring basis, the risk factor will increase to our business. In these circumstances the account terms may be reduced, ultimately to C.O.D. terms if non-compliance continues.
- 5. It is a condition that before accounts can be approved, the 'Retention of Title' (Section D) and 'Guarantee for Companies' (Section E) must be completed in full.
- 6. All goods will remain the property of Western Pet Supplies until payment is made in full.
- 7. The Customer agrees to also pay the costs and expenses incurred in respect of any enforcement or recovery of either the monies owing by the customer or repossession of the goods.
- 8. Discounts may not apply and the supply of goods may be suspended if these terms are not adhered to.
- 9. Western Pet Supplies reserves the right to vary its credit terms for any customer at its discretion.
- 10. Interest of 10% per annum will be charged on overdue accounts.

DELIVERIES

- 1. Western Pet Supplies will reserve the right to charge a freight charge on deliveries.
- 2. We require that CHEP pallets be exchanged at time of pick up/delivery. Where CHEP pallets are not exchanged, a charge of \$30 + GST per pallet will be levied without exception. If pallets are subsequently returned, a credit will be issued.

DISHONOURED CHEQUES

A fee of \$15.00 will be billed for all bank charges on re-presented cheques; Dishonoured cheques that refer to drawer will be billed at \$20.00. A \$250.00 fee for legal costs to recover any payment due for goods will be worn by the purchaser. Future payments may be requested by bank cheque or cash.

CREDITS AND CLAIMS

- 1. All goods should be checked on arrival. Any discrepancies should be notified to us within 48 hours of receipt of goods, otherwise claims might not be recognized.
- 2. No credit claim will be investigated unless the claim is supported by the relevant invoice number.
- 3. No goods shall be accepted for return unless authorised by a representative of our company. Our drivers cannot accept goods for return unless prior arrangements have been made.
- 4. Goods may not be accepted for credit in a damaged or defaced condition that is other than a fault in manufacture or the fault of Western Pet Supplies.

WARRANTIES

All goods that carry a warranty of guarantee of the manufacturer or agent shall be credited or exchanged only once agreed to by that manufacturer or agent.

BACK ORDERS

Goods that are temporarily out of stock at the time of dispatch of orders will not be placed on backorder unless specifically requested by the customer.

PRICES

- 1. All prices quoted are exclusive of Goods and Services Tax (GST), and where applicable will be charged in accordance with GST Legislation.
- 2. We offer you a various range of products from multiple manufacturers and brands at competitive prices, however Western Pet Supplies reserves the right to alter prices without notification.
- 3. Discounts and specials that are offered will be shown on invoice, and not accepted by claim off remittance.
